Submitting this form:

- 1. Club or group representatives complete this application and submit to the Local Extension agent.
- Agent will sign and remit to the State 4-H Office by email <u>kansas4h@ksu.edu</u> or by mail: Kansas 4-H Youth Development, 1612 Claflin Rd., 201 Umberger Hall, Manhattan, KS 66506.

Once complete, the State 4-H Office will mail the charter certificate to the Local Extension agent. It is recommended to make a copy to keep on file in the Extension office. The Agent will see that an appropriate charter presentation is made to group members and leaders.

Instructions on Obtaining an EIN for your Chartered 4-H Club or Group

If a 4-H club or group plans to manage funds, a <u>SS-4 Form</u> must be completed by the local Extension agent to obtain an EIN.

Here is an <u>example of a completed SS-4 Form</u> to assist with completion. This form should be faxed or mailed to the IRS.

You should receive your EIN number by fax in about one week. If you forget to include your return fax number it may take two weeks.	You should receive your EIN number by mail within four to five weeks.	

Once you receive your EIN number, file an <u>8821 Form</u> with the State 4-H Office to <u>kansas4h@ksu.edu</u>. Here is an <u>example of a completed 8821 Form</u> to assist with completion.

Tax Exemption Letters

As a special service, the State 4-H Office will issue a club "tax exemption letter" to local Extension offices who make this request. This letter describes entity exemption from Federal income tax and cites applicable IRS sections pertaining to contributions and income exclusion. Most organizations will accept the letter as the substantiation they need.

Lost or Misplaced EIN Numbers

If you have an EIN number but have misplaced it, you may ask the IRS to search for your EIN by calling the Business & Specialty Tax Line at 800-829-4933. The hours of operation are 7am – 7pm, local time, Monday through Friday.
